1. Sanction is hereby accorded as under: -
Government Order No: 640-GAD of 2001 dated: 14-06-2001 is deemed to have been withdrawn.

2. The Social Forestry Project shall and shall always be converted into a department and is named as "Department of Social Forestry". The staff strength of the department of Social Forestry shall be as indicated in Annexure - A.

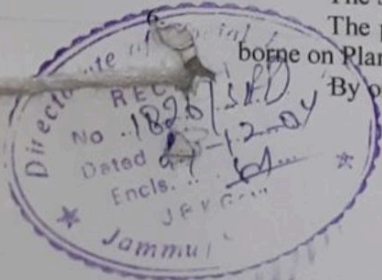
3. The Department of Social Forestry is entrusted with the assignment of giving thrust to Agro Forestry in the state besides development of medicinal plants on commercial lines, under the Joint Forest Management programme and as per the guidelines of S.R.O. - 61 of 1992 and S.R.O. - 17 of 1999.

4. The new Department will maintain all the assets created under the Social Forestry Project and in addition will continue with the following activities:

- i) Raising of Village Wood Lots
ii) Rehabilitation of Degraded Forests
iii) Raising Strip Plantations
iv) Farm Forestry
v) Institutional Plantations.

5. The Social Forestry activities shall be funded from the Plan funds of the State.

6. The posts which are proposed to be reverted back to Forest Department shall also continue to be borne on Plan funds. Orders in respect of these posts shall be issued separately
