Whereas, Shri Satish Kumar Gupta S/o Late Shri Bansi Lal Gupta R/o. Krishna Nagar P/o Miran Sahib Tehsil R. S. Pora, was appointed as Orderly in this Department under SRO-43 of 1994 by the Administrative Department vide Government Order No:402-FST of 2009 dated:23-10-2009 read with Government Order No:82-FST of 2010 dated: 18-02-2010 and he joined the Department on 20-02-2010 & was paid salary from the date of joining up to May 2018 regularly;

Whereas, it had been reported to this office that the official has not attended his duties since 03.06.2018 and not applied for any kind of leave thereof and his whereabouts are not known and he is un-authorizedly absent from his duties;

Whereas, accordingly, 1st show cause notice to this effect was issued vide this office No: DIR/ DSF/ Estt/804-07 dated:11-07-2018 and dispatched to his home address, and was published in Daily Excelsior on 12-07-2018, but no response was received from the official;

Whereas, the official was placed under suspension vide S. F. Order No: 71 of 2018 dated: 14-08-2018 issued under endorsement No: DIR/ DSF/ Estt/ 250 dated: 14-08-2018 w.e.f 03-06-2018 i:e from the date of his absconding;

Whereas, 2nd show cause notice to this effect was issued vide this office No: DIR/ DSF/Estt/1358-61 dated: 31-08-2018 and dispatched to his home address, and was published in Daily Kotli Times Jammu on 02-09-2018, but again no response was received from the official;



Whereas, final show cause notice was issued vide this office No: DIR/DSF/ Estt/1670-73 dated:15-11-2018 and dispatched to his home address, also published in two leading dailies News Papers of Jammu on 19-11-2018, and uploaded on official website (www.jksocialforestry.nic.in) of Social Forestry Department J&K as well, whereunder the official was given final chance to resume his duties with justifications within 14 days from the date of publication of the notice and was warned that in case he failed to resume his duties with justifications, his services will be terminated under rules without any further notice, but till date no response has been received from the official;

Whereas, the official has been given all the opportunities under rules to resume his duties with proper justifications but he failed to respond in any manner;

Now, in view of the above circumstance, the services of Shri Satish Kumar Gupta S/o Late Shri Bansi Lal Gupta R/o Krishna Nagar P/o Miran Sahib Tehsil R. S. Pora District Jammu, Orderly of Social Forestry Department (Direction Office) are hereby terminated w.e.f 03-06-2018, in light of Article 128 CSR (Volume-I).
