Whereas, Shri Sidharth Negi S/o Late Shri Raman Kumar Nagi R/o. House No: F-224, Hari Singh Nagar Rehari Colony Jammu, was appointed as Jr. Assistant vide Government Order No:177-FST of 2014 dated:29-05-2014 under SRO-43 of 1994 by the Administrative Department in Social Forestry Department and joined Directorate of Social Forestry on 09-06-2014.

Whereas, the official was paid salary from the date of joining up to April 2015 regularly, and official applied for 12 days casual leave w.e.f 11-05-2015 alongwith station permission, but the leave was not sanctioned in view of the fact that the official had already availed 14 days casual leave during the calendar year 2015 upto April 2015. Moreover the official did not return after the end of leave.

Whereas, show cause notice was issued vide this office letter No:DIR/DSF/Estt/200 dated:15-05-2015 and dispatched to his home address, but no response has been received from the official.

Whereas, 2<sup>nd</sup> show cause notice was issued vide this office letter No:DIR/DSF/Estt/817-18 dated:08-08-2015 and dispatched to his home address, but no response has been received from the official.


Whereas, final show cause notice was issued vide this office letter No:DIR/DSF/Estt/198-200 dated:14-05-2016 and dispatched to his home address, also published in two leading dailies News Papers of Jammu/Kashmir, and uploaded on official website ([www.jksocialforestry.nic.in](http://www.jksocialforestry.nic.in)) of Social Forestry Department J&K as well, but till date no response has been received from the official.
