On the recommendations of the J&K Service Selection Board vide their communication number cited above read with Administrative Department (Forest)'s letter No. FST/CORD/14/2021-02 dated: - 12.06.2025 and subsequent satisfactory character & antecedents report received from the special DG CID, **Shri Vishal Kumar (SC) S/o Shri Rajesh Kumar** R/o MCJ-742 Rajpura Mangotrian, opposite Govt. Girls High School Jammu is hereby appointed as Junior Assistants in the Department of Social Forestry (Divisional Cadre Kashmir) in the Pay Scale of Level-4 (Rs. 25500-81100). However, to maintain inter-se-seniority, the said appointment shall be notionally w.e.f 24-07-2025 and monetarily with immediate effect.

The appointee shall report to the concerned DDO as mentioned against his name below, within a period of twenty-one (21) days from the date of issuance of this order, failing which he shall forego his right to appointment, and the same shall be deemed to have been cancelled ab-initio without any further notice.

The appointee shall be allowed to join only on the production of the following certificates (*in original*) to be verified subsequently:

- i. Academic/Qualification Certificates.
- ii. Matriculation/Date of Birth Certificate.
- iii. Health Certificate from the concerned Chief Medical Officer of the District.
- iv. Domicile Certificate issued by the Competent Authority.
- v. Valid relevant Category Certificate, if any, applicable.

The appointment of the above candidate shall further be subject to the following conditions:

- a. The appointee shall give an undertaking in the shape of an affidavit to the effect that if on verification, his Qualification/Date of Birth/Reserved Category Certificates is found fake/forged, his appointment as Junior Assistant in the Department of Social Forestry, shall be deemed to have been cancelled abinitio and the legal action as warranted under rules shall be initiated against him.
- b. That if the candidate has taken loan for self-employment from DIC / Employment Department, to be ascertained from the District Industries Centre (DIC) and District Employment & Counselling Centre of the domicile District, he shall relinquish the proprietorship of unit/enterprise and also stakes, if any, in such self-employment unit/enterprise before joining the Government service. He shall be required to repay the entire loan liability in suitable EMIs to be worked out by the DDO concerned from his salary. DDO concerned shall obtain an affidavit from the concerned appointee

regarding both relinquishment of proprietorship and stakes, if any, in such a self-employment unit/enterprise and recovery to be made and also personally monitor its recovery.

- c. The salary of the appointee shall not be drawn and disbursed to him unless the satisfactory reports in respect of genuineness of Qualification/Date of Birth/Relevant Category Certificate (if applicable), is received from the concerned Authorities/Agency.
- d. The appointee shall be on probation for a period of two years.
- e. The appointment of the candidate shall be governed by the "New Pension Scheme" as notified vide SRO-400 of 2009 dated 24.12.2009.
- f. The inter-se-seniority of the appointee in the Department of Social Forestry (Divisional Cadre Kashmir) shall be determined as per the J&K Civil Services (Classification, Control and Appeal) Rules, 1956.
- g. The appointment of the above appointee shall be subject to outcome of writ petition(s), if any, pending before Competent Court of law.
